The variables in the research are study interest and career motivation. The research method uses quantitative correlation research with data collection using questionnaires in the form of questionnaires via Google Form. The sample for this research consisted of 25 first semester students. The data analysis technique is simple linear regression with Prerequisite Test and Hypothesis Test. The results of the research show that there is a significant relationship between variables Continuing studies has various benefits, including the opportunity to get the right position and being able to increase confidence and abilities in certain scientific fields in the world of work and also as personal development itself as well as several benefits in implementing modern teaching, being able to recognize the potential of students, learning that focuses on students students where the presentation of material is project-based as an output from the Independent Curriculum.

Abstrak

The results of research by Linda Dwi et al state that, various aspects that influence career motivation include discipline, responsibility and resistance to pressure, these have a significant influence on a person's performance, both initiative and quality. One of the most important aspects of education is assessment of learning, namely through student learning

(Taluke et al. 2019) In formulating instruments for both variables whether the data is valid and consistent or not through the IBM SPSS Statistics 25 program. The data collection technique uses a questionnaire, (Creswell 2017) with data analysis using a simple linear regression analysis technique, with 1) Prerequisite tests including Normality Test & Data Linearity Test and 2) Hypothesis testing.

RESULTS AND DISCUSSION

After collecting and calculating the data, it shows that: from the results of the validity test the two variables were declared valid, while the data reliability test for the Study Interest instrument was 0.732
